- Sealed Bids must be submitted to Surma Rural Municipality Office on or before 12.00 hours on 31st day from the date of publication. Documents received after this deadline shall not be accepted. For submission of hard copy, the bid documents purchased from Surma Rural Municipality is only acceptable.
- In the case of discrepancies or error in bid documents, bid notice or any other documents, Surma Rural Municipality reserves the right to amend and correct at any time. The figure for the bid amount must be clear if any discrepancy may occur then the figure written in word is valid.
- Bids shall be opened in the presence of Bidders' representatives, who choose to attend with original related documents at 2:00 PM on 31th day of Notice Published in Surma Rural Municipality, Bajhang. Bids must be valid for a period of **90 days** counting from the day of bid opening.
- Bid shall be accompanied by a bid security of an amount as shown in the above table. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in the following address or a bid bond issued by a bank approved by Nepal Rastra Bank valid beyond a month from bid validity period and submit the original receipt of the deposited amount of cash along with the bid.
